



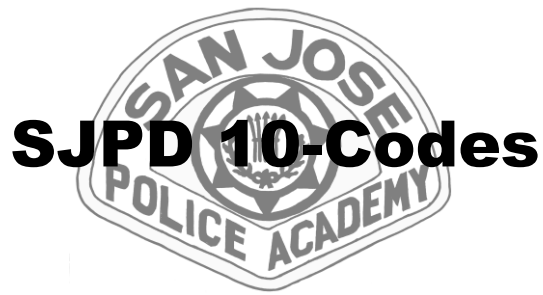

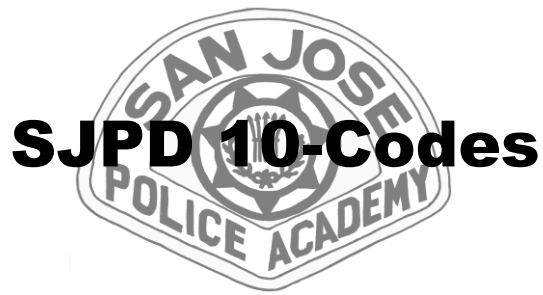
Reasonable Suspicion:

A specific set of describable facts or circumstances that would cause a reasonable officer, of like training and experience, to suspect that:

- Suspicious activity is afoot, and
- The person to be detained is connected to that activity, and
- The activity may be related to a crime.

Probable Cause:

A specific set of describable facts or circumstances that would cause a reasonable person of ordinary care and prudence (or a reasonable officer, of like training and experience), to entertain an honest and strong belief that the person to be arrested is guilty of a crime.

835 PC: Method of Arrest

- An arrest is made by actual restraint of the person or by submission to the custody of an officer.
- Reasonable restraint for the arrest and detention may be used.

835a PC: Effecting Arrest; Resistance

- Any peace officer who has reasonable cause to believe the person to be arrested has committed a public offense
- May use reasonable force to:
 - o effect the arrest, or
 - o to prevent escape, or
 - o to overcome resistance.

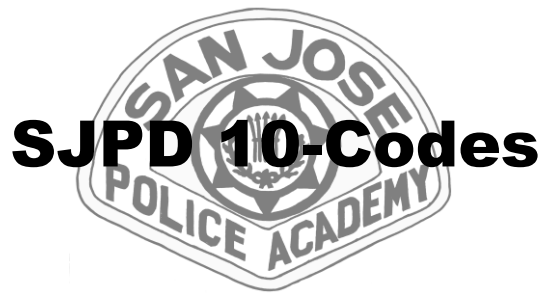

- Theft of any item exceeding a value of \$950

488 PC: Petty Theft (MISDEMEANOR)

- Theft in other cases is petty theft

- against the person's will
- by means of force or fear.

215 PC: Carjacking (FELONY)

- Taking of a motor vehicle
- from the person or immediate presence
- of a possessor or passenger
- by means of force or fear
- with the intent to either permanently or temporarily deprive the possessor or passenger.

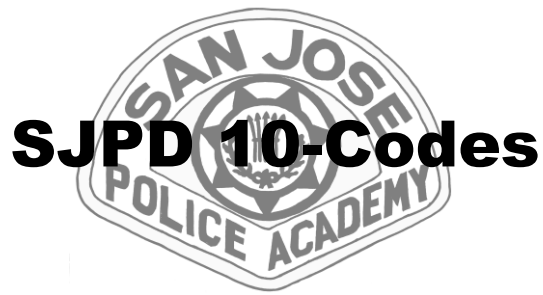

- Loss of consciousness
- Concussion
- Bone fracture
- Protracted loss or impairment of body member/organ
- Wound requiring extensive suturing
- Serious disfigurement

245 PC: Assault with a Deadly Weapon (FELONY)

- Unlawful attempt, and
- the present ability,
- to commit a violent injury
- upon the person of another
- by use of a deadly weapon
- or force likely to produce great bodily injury.

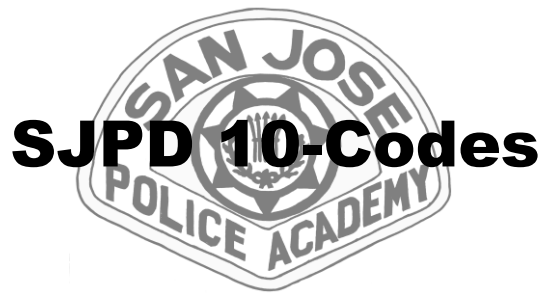

602 PC: Trespassing (MISDEMEANOR)

- Any person who enters and occupies
- real property or structures of any kind
- without consent of the owner, the owner's agent, or the person in lawful possession, or
- refusing to leave upon request.

- his or her official duties.

148.9 PC: Giving False Information (MISDEMEANOR)

- Any person who
- falsely represents or identifies oneself as another person (real or fictitious)
- to a peace officer during a lawful detention or arrest
- to evade the process of the court or arrest.

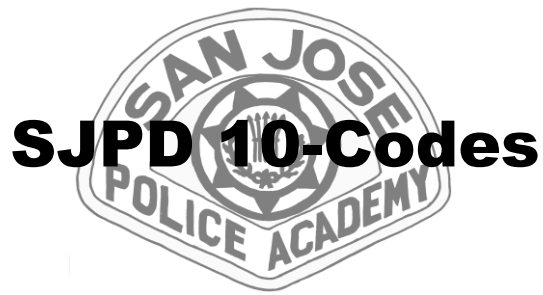

- disables, disfigures, or renders it useless, or
- cuts or disables the tongue, or
- puts out an eye, or
- slits the nose, eye, or lip.

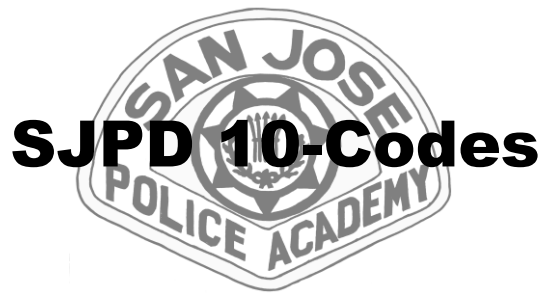

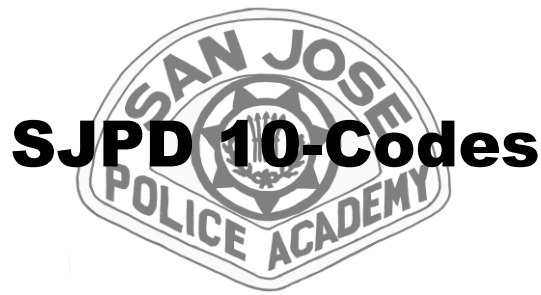

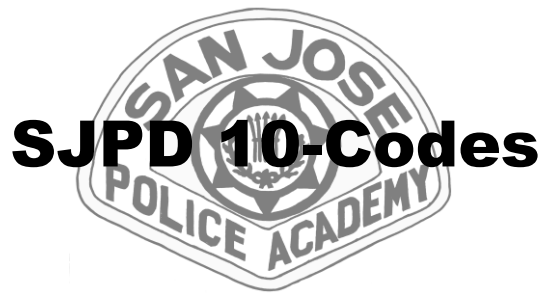

- a spouse, former spouse, cohabitant, former cohabitant, current or former dating relationship partner, current or former engagement partner, or a person with whom they have a child with,
- a corporal injury resulting in a traumatic condition; internal or external, minor or serious.

243(e)(1) PC: Domestic Violence (MISDEMEANOR)

- Any person who commits force or violence against,
- a spouse, former spouse, cohabitant, current or former dating relationship partner, current or former engagement partner, or a person with whom they have a child with.
