

# Text Formatting

Lesson Plan – 8 Hours

- I. 5 W's
  - a. WHAT (what is going on?)
  - b. WHERE (1020 where are you sending the police ?)
  - c. WHEN DID THIS OCCUR (Time Element?)
  - d. WEAPONS (What kind, Who has them ?)
  - e. WHO (Suspect, Victim, Involved parties ?)
- II. SJPD Priorities
  - a. Priority 1 events
    - i. There is a present or imminent danger to life
    - ii. There is major damage to/loss of property, i.e.
    - iii. Large-scale incident or cases where there is an in-progress or just occurred major felony.
    - iv. District and/or channel-wide response (district wide pertains to units within the district of the call for service only whereas channel wide pertains to any units on the channel involved.).
    - v. The incident may have an immediate impact on and need for citywide police resources.
    - vi. Examples
      - 1. FILL3, C20, C30, C1000, or similar multiple casualty incidents.
      - 2. 211A occurred within 10 minutes
      - 3. 1033S hold-up alarm 459 in progress
      - 4. 415W (weapon seen).
  - b. Priority 2 events
    - i. District wide response when a crime is in progress or has just occurred
    - ii. There are injuries or there is the potential for injury
    - iii. The suspect is still present in the area
    - iv. All missing person reports where the children are under the age of 12, or at risk missing persons, including mentally handicapped or disoriented adults.
    - v. Situations where the suspect is in custody for any violent crime, or for a nonviolent crime and is uncooperative
    - vi. Examples
      - 1. 415A
      - 2. 1053PD or 1053EMS
      - 3. 1179
      - 4. Outside Agency Aid Calls
  - c. Priority 3 events
    - i. District wide response when a crime has just occurred.
    - ii. There is property damage or the potential for it to occur.
    - iii. The suspect has most likely left the area.

- iv. Situations where the suspect is in custody for a non-violent crime and is cooperative.
- v. Situations when a prior crime against the person occurred, and There are no injuries to the victim necessitating immediate medical care, and the suspect is not present.
- vi. Examples
  - 1. 1125
  - 2. 1182 when 1125
  - 3. Civil Standby
  - 4. 459R
  - 5. 20002

d. Priority 4 events

- i. A District wide response to a non-violent crime when there is no present or potential danger to life/property, and one or more of the below:
  - 1. The suspect is no longer in the area.
  - 2. Beat or district information.
  - 3. Details in the event are for broadcast purposes only.
  - 4. The response may be handled sometime during the shift.

ii. Examples:

- 1. 415M
- 2. PATCK
- 3. INFO
- 4. 1021
- 5. CODE5
- 6. 484BOL
- 7. FNDPRP

e. Priority 5 and 6

- i. Priority 5 is automatically assigned to events that officers "on view."
- ii. Priority 6 is automatically assigned to administrative dispatches on all car and person stops. If an officer changes the type code on these events, the dispatcher shall ensure the priority 6 is maintained.

III. Time Element

- a. 1 ago, 3 ago, 10 ago, 1 hour ago.
- b. Just occurred
- c. Last night
- d. FM ago

IV. What is occurring to support Type Code

- a. 3 men walked by store w/guns.
- b. Mom vs dad, verbal.
- c. Car taken at gunpoint.
- d. Veh vs Ped
- e. 4 y/o missing for 45 mins.
- f. Person Shot or stabbed

V. Officer Safety Questions

- a. Weapons (what type?)
  - b. Drugs (what kind?)
  - c. Alcohol
  - d. Swimming Pool
  - e. Pets? (Dogs, cats)
- VI. Suspect Descriptions
- a. Name: L/N , F/N
    - i. [REDACTED]. [REDACTED]
  - b. SHOOTER, SUSP#1, DRIVER, PASSENGER.
  - c. Race, Gender and Age
    - i. WMA, WFA, BMA, BFA, HMJ, VMJ
  - d. Height & Weight
    - i. 6'01", 180. 5'9/200, 507/145
  - e. If suspect unknown use how he/she is related to call.
  - f. Hair & Eye Color.
    - i. BLK/BRN, RED/GRN, BLN/BLU
  - g. Clothing Descriptions are top to bottom and outside in
    - i. LSW BLU JKT, WHI SHIRT, BLU JEANS
    - ii. LSW WHI HAT, TAN DRESS, WHI BELT
- VII. WEAPONS

    - ii. LS ACR (X ST) STREET FRM
    - iii. LS TWDS HY 101 FRM KING
    - iv. LS MAKING LEFT ON JORDAN WAY
    - v. IN PLOT OF \_\_\_\_\_.
