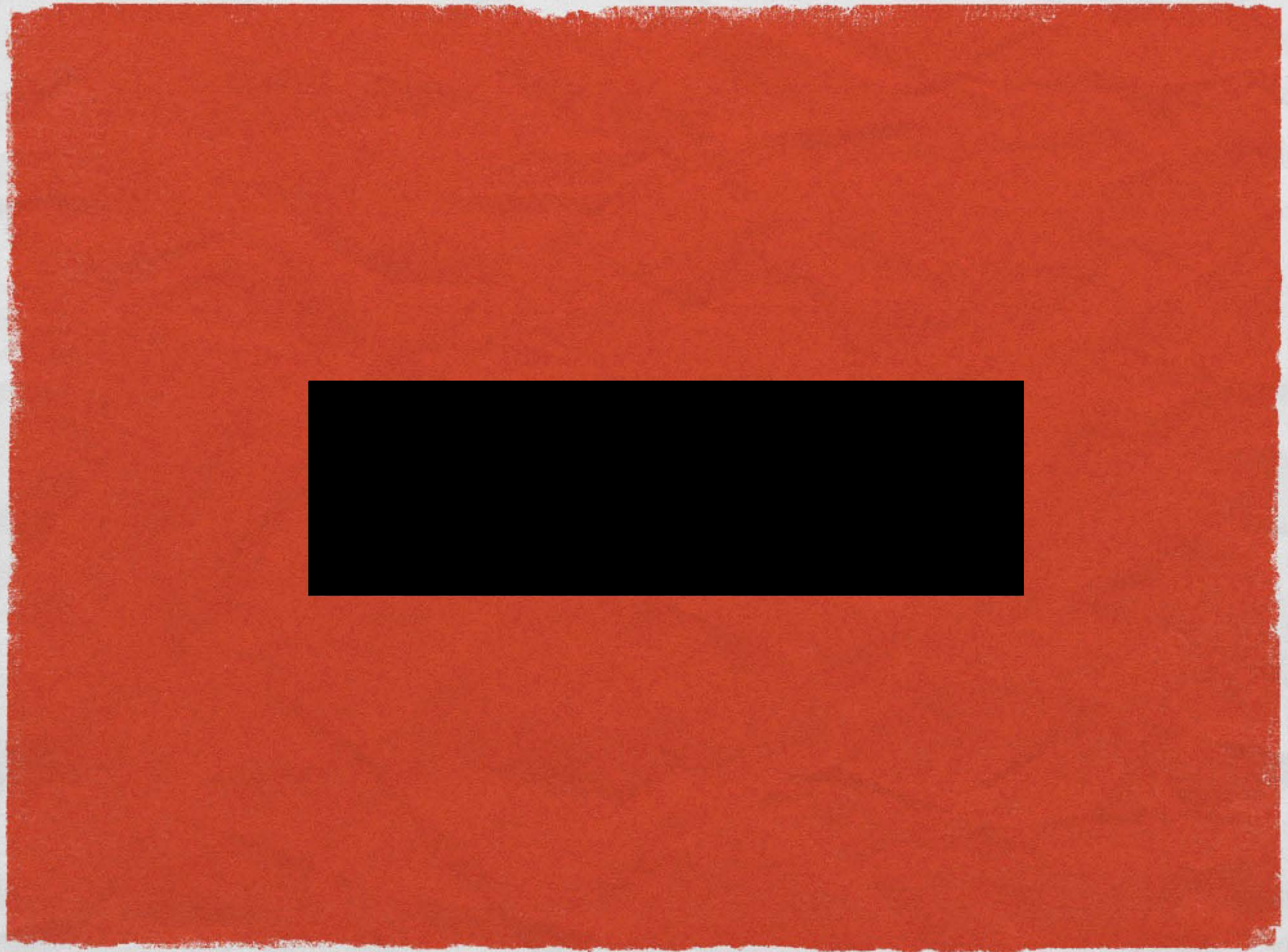

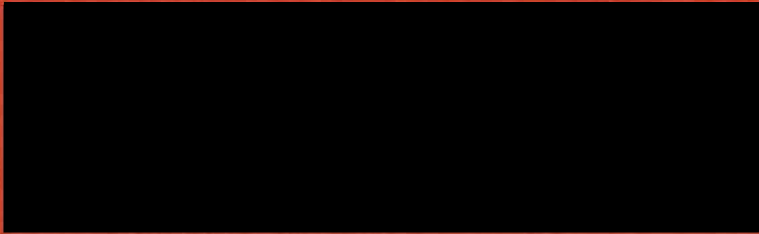
# TRENDS WE SEE

- Winter time = Warm ups

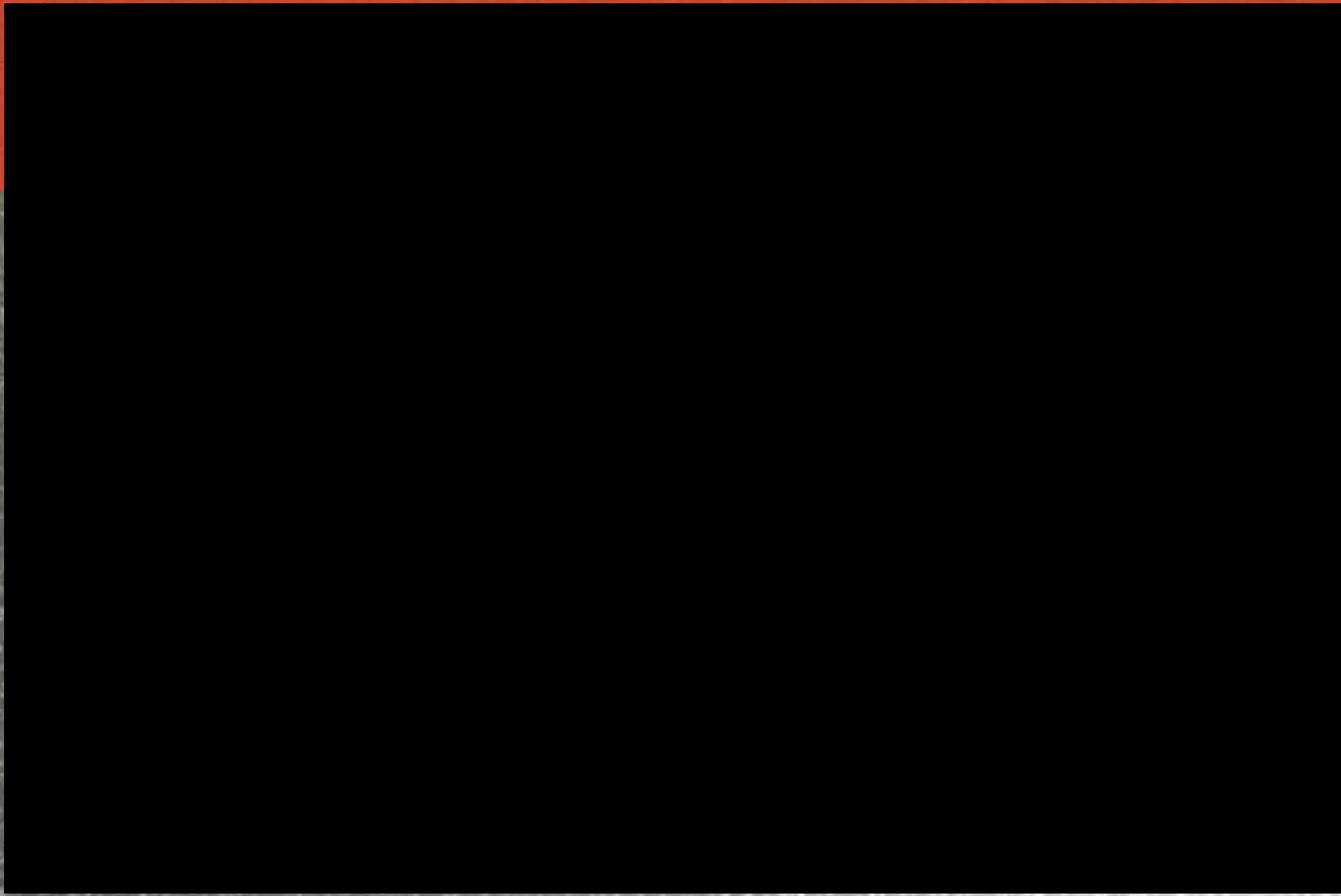

# VIN (VEHICLE IDENTIFICATION NUMBER)

- Located throughout the vehicle
- 1970 - All passenger cars had a visible Vin in window and Federal Label inside Driver's side Door
- 1980 – All light duty trucks had a visible VIN in window
- Manufacturers are responsible for Vin configuration = no uniformity
- Only thing regulated is all vehicles have a 17 digit VIN

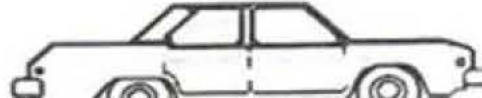

# NARRATIVE (STOLEN)

On [REDACTED] I was dispatched to the area of [REDACTED] in San Jose regarding a report of a stolen vehicle.

# NARRATIVE (RECOVERY)

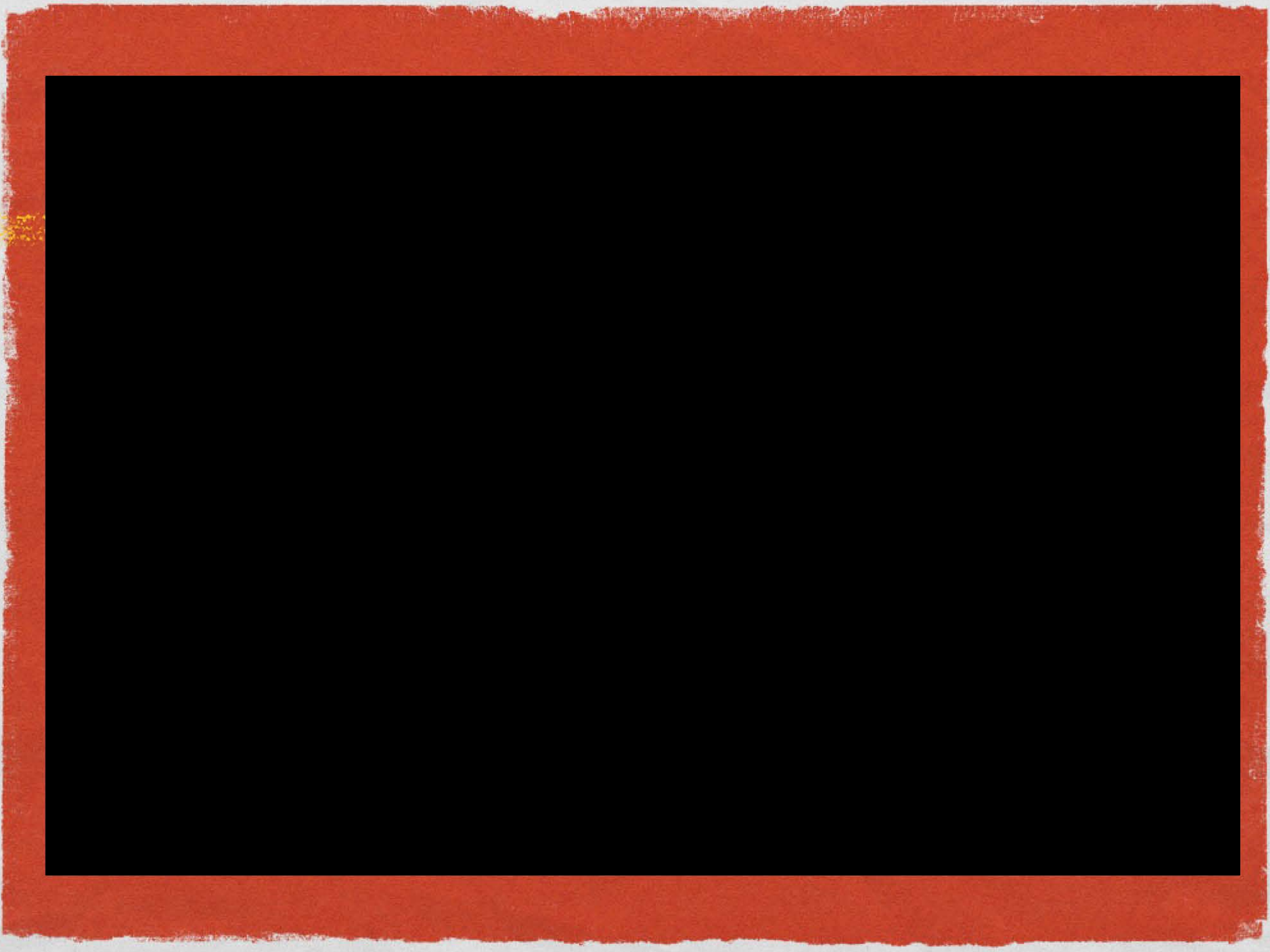
On [REDACTED] hours, I was dispatched to the area of [REDACTED] in San Jose regarding a previously reported stolen vehicle that had been located by the registered owner.

Several Latent fingerprints were located, photographed and collected from the vehicle's interior.

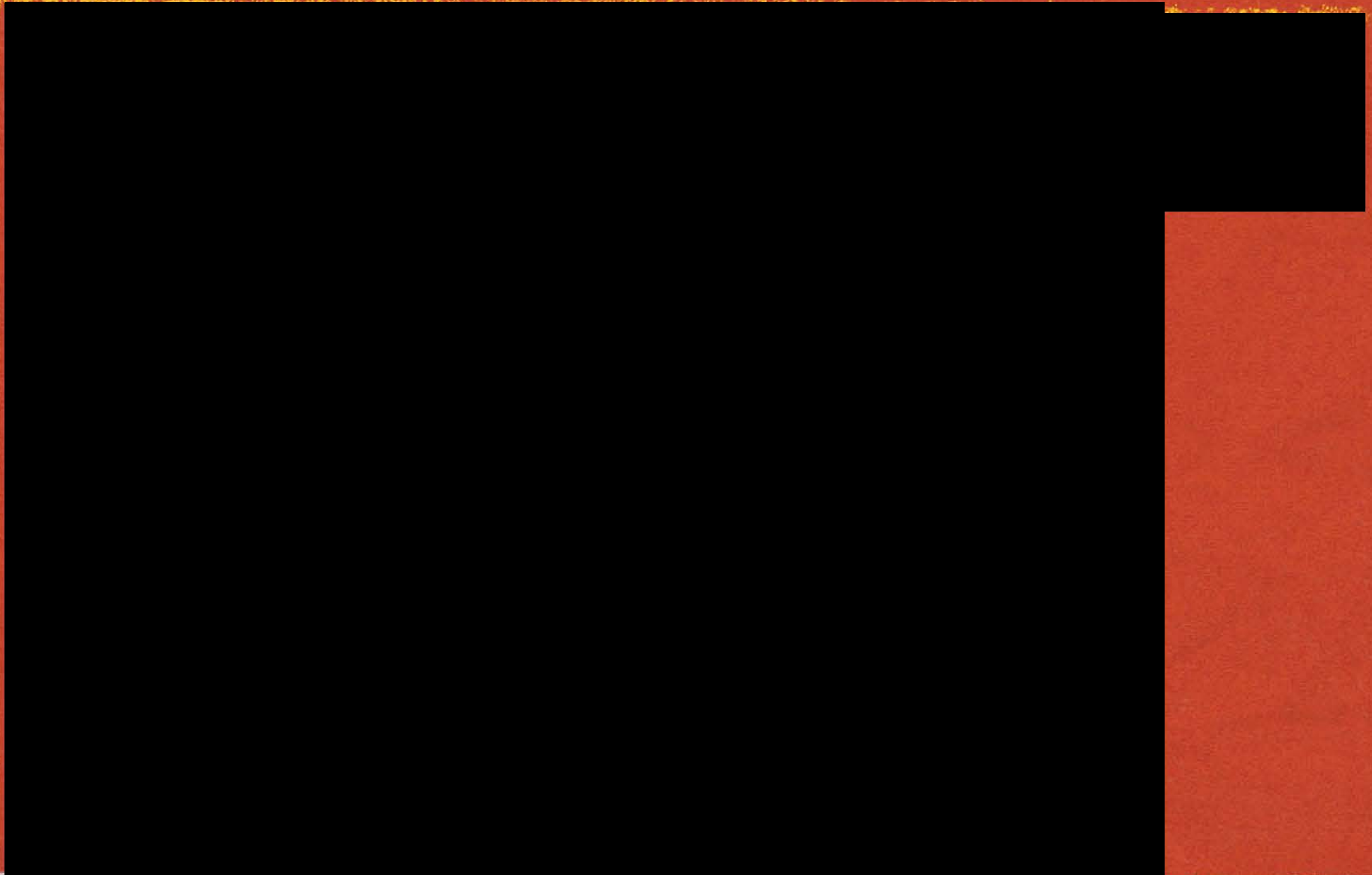
The registered owner took position of the vehicle on scene. The Latent fingerprints were dropped at central ID at the end of my shift.







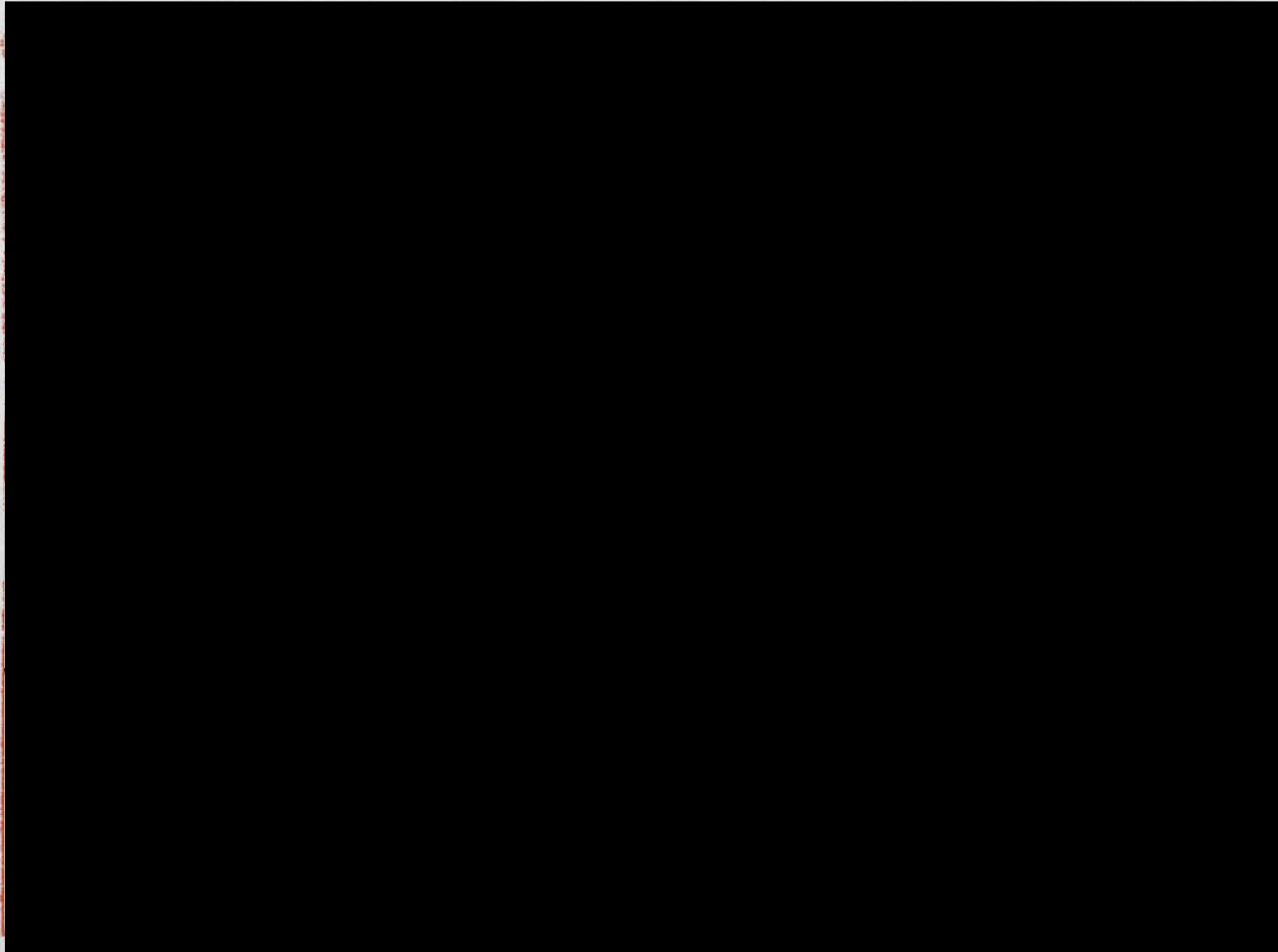
