

LD-2 Criminal Justice System: Law Enforcement Agency Summary

FEDERAL AGENCIES	MISSION
Department of Homeland Security	To ensure the Homeland is safe, secure, and resilient against terrorism and other hazards.
Federal Bureau of Investigation (FBI)	Protect against terrorism/foreign intelligence, enforce federal criminal law, and provide CRJ Leadership.
Drug Enforcement Agency (DEA)	Enforce U.S. drug laws, recommend and support non-enforcement programs to reduce drug use in the U.S.
U.S. Marshal Service	Federal courthouse security, fugitive apprehension, prisoner security & transport, witness protection.
Immigration and Customs Enforcement (ICE)	Enforces federal laws governing border control, customs, trade, and immigration.
Alcohol, Tobacco, and Firearms (ATF)	Enforces illegal use & trafficking of firearms / explosives and the illegal diversion of alcohol & tobacco.
Secret Service	Dignitary protection & investigation of financial crimes.
U.S. Postal Inspectors	Enforcing U.S. mail laws & protection of postal employees, infrastructure, and customers.
Armed Forces Police	Enforce the Uniform Code of Military Justice amongst military personnel and on military facilities.

STATE AGENCIES	MISSION
Youth and Adult Correctional Agency	Various agencies that run adult and juvenile prisons and supervised release programs.
California Highway Patrol (CHP)	Promoting safety of highways & motorists through law enforcement, safety programs, and local assistance.
Department of Alcoholic Beverage Control (ABC)	Regulates businesses selling alcohol and enforces state alcohol laws.
Department of Fish and Game (F&G)	Manages State fish, wildlife, and plant resources. LEO division enforces hunting and fishing laws.
Department of Forestry and Fire Protection (DOF)	(CAL FIRE) provides fire, rescue, and medical protection in the state's 31 million privately owned wildlands.
Office of State Fire Marshal (SFM)	Part of CAL FIRE: fire law/code enforcement, education programs, arson investigations for CAL FIRE areas.
Department of Justice (DOJ)	Maintains CRJ databases, office of the Attorney General, assists local agencies with crime scene forensics.
Department of Insurance (DOI)	Investigates insurance fraud, prosecutes offenders, provides anti-fraud outreach and training.
Department of Motor Vehicles (DMV)	Enforces laws related to auto dealers/schools/businesses. Investigates counterfeit/fraudulent DMV docs.
Department of Parks and Recreation (DPR)	LEO Park Rangers: enforce laws in the state parks, search & rescue, emergency medical aid.
Franchise Tax Board (FTB)	LEO agents investigate tax fraud, identity theft, embezzlement, etc. Participate in joint task forces.
University / College Police Departments	Perform all LEO functions on state university and college campuses.
Department of Health Services (CDHS)	LEO agents investigate beneficiary fraud and abuse of the Medi-Cal program.

LOCAL AGENCIES	MISSION
Airport Police	Perform all LEO functions within airport boundaries. Provide armed security for TSA at checkpoints.
County Marshals	Perform security and LEO functions at county court houses in some California Counties.
Housing Police	Perform all LEO functions in some publicly owned housing neighborhoods throughout California.
Municipal Police	Perform all LEO functions within the boundaries of incorporated cities, towns, and villages.
School District Police	Perform some LEO functions for various school districts throughout California.
Sheriff's Departments	Perform all LEO functions in unincorporated areas of the county, often protect courts and oversee jails.
Transportation Police	Perform most LEO functions on transit systems that cross multiple jurisdictions (i.e. BART Police).
Port Authority Police	Protect various ports of entry from criminal activity or hazards.
