DETAILS:

On June 10, 2004 at 6:16PM, San Jose officers responded to 233 N.White Rd. on a report of a male shot inside the Gaslight Bar. On arrival, officers located two gunshot victims inside. Victim 1 was pronounced dead at the scene. Paramedics rushed the second victim to a local hospital where he later died from his injuries.

Homicide Investigators and Crime Scene Technicians responded to the scene. Preliminary investigation indicates that four Hispanic males entered the bar and had a brief conversation with victim #1. During the conversation one suspect drew a firearm and opened fire on the victims. The suspect fled the bar prior to police arrival. He was last seen getting into a white or light blue Bronco with a horizontal stripe along the side. Detectives have not yet established a motive for this incident.

UPDATE: 6-15-04

Follow-up investigation by Homicide Detectives identified a possible suspect in this case as Enrique Gutierrez of San Jose. Detectives began attempting to locate the suspect with the assistance of our MERGE Surveillance/Enforcement Team. MERGE Officers developed information that the suspect was located in the city of Santa Clara. Officers from the Santa Clara Police Dept.'s Special Enforcement Team set up surveillance in the area while Santa Clara Patrol Officers waited nearby.

At about 9:00PM, the surveillance officers spotted the suspect at the location. MERGE Officers and Santa Clara Police Officers then stopped the suspect and arrested him without incident. He was arrested and taken to the San Jose Police Dept. for processing. He was later booked into the Santa Clara County Jail for two counts of murder. No other suspects are being sought in this case.
