SUSPECT DESCRIPTION:

An Hispanic male adult, 27-30 years of age, approximately 5'6" to 5'8", 140-150 lbs., described as clean shaven, having bad teeth and with dark brown or black hair in a buzz or crew cut. He was last seen wearing a dark blue hooded sweatshirt, a blue or white tank top, olive green pants and black shoes. (Sketch Available)

SUSPECT VEHICLE:

None seen.

DETAILS:

On 3-7-05 at about 1:15 PM, the victim was walking in the area of Capitol Expressway, between Highway 101 and Silver Creek Road. She walked to the strip mall at the SW corner and then stepped back out onto Capitol Expressway to smoke a cigarette. She saw the suspect watching her from a distance.

The victim began walking on Capitol Expressway back towards Highway 101, when the suspect came up behind her, grabbed her and dragged her into some nearby bushes. The suspect sexually assaulted the victim. After the assault, the suspect was last seen walking eastbound on Capitol Expressway, towards Silver Creek Road.

Investigators have a sketch of the suspect, which they are releasing in the hope that the public can help identify him.
