**DETAILS:**

On 3-30-05 at 2:40PM, San Jose Police Officers responded to reports of five subjects fighting with knives near the intersection of Story/McLaughlin. It was reported that one subject was armed with a machete and that four subjects were attacking one subject. Witnesses reported several subjects leaving the scene in a white vehicle. Officers were unable to locate anyone when they arrived.

At 2:57PM, a local hospital reported that they had a person arrive at the emergency room with a stab wound to the chest. It is believed that he was involved in the fight at Story/McLaughlin. He died at the hospital at 3:04PM.

**UPDATE: 04-15-05**

Follow up investigation by Homicide Detectives led to the apprehension of three juveniles on 04-14-05. Suspect #1, age 15, was booked into Juvenile Hall for Murder. The other two suspects, ages 15 and 17, were booked into Juvenile Hall for Accessory to Commit Murder. All suspects are San Jose residents.

**UPDATE: 04-19-05**

On 04-15-05, a fourth suspect, age 14, was booked into Juvenile Hall for Aiding and Abetting. All suspects have received Gang Enhancement booking charges. Detectives know other people have pertinent information on this case.
