### **DETAILS:**

On Friday, 04-22-05, at 9:00 AM, a San Jose Police Officer was working security at Branham High School. The officer noticed the suspect, a Teacher's Aide, displayed symptoms of stimulant influence. The officer met with school administrators to discuss the situation.

During their conversation, the officer learned the suspect was possibly involved in inappropriate behavior with a male student.

Detectives from the Child Exploitation Detail responded to the school and took over the investigation. Detectives discovered the suspect was having a sexual relationship with a male student and providing him with illegal narcotics. The suspect was booked into Santa Clara County Jail for Unlawful Sexual Intercourse, Oral Copulation, Child Endangerment, Providing Narcotics to a Minor and Being Under the Influence of a Stimulant.
