DETAILS:

On Friday, May 6, 2005, at about 1:30PM, Earl Roske was arrested in his home for an outstanding one million-dollar warrant for one count of Unlawful Sexual Intercourse, two counts of Oral Copulation with a Minor, two counts of Using a Minor to Produce Child Pornography and two counts of Sending Harmful Matter to a Minor.

Detective Robert Dillon began an investigation after a friend of one of the victims notified the San Jose Police Department of inappropriate sexual activity. The investigation revealed Roske had a sexual relationship with the victims; he used a web-cam to send sexually explicit images of himself to victims; he had the victims produce pornographic images of themselves; and he took sexually explicit photographs of the victim's in his classroom.

Roske was booked into Santa Clara County Jail. Detectives believe there may be additional victims in this case and are asking anyone with information to contact them.
