DETAILS:

On 5-22-05 at 12:10PM, the parents of the 12-year-old victim came to the San Jose Police Department with evidence that their child was the victim of child molestation by the suspect. Detectives David Gonzales and Robert Dillon from our Child Exploitation Detail / Internet Crimes Against Children Task Force began an investigation into the allegations.

Detectives learned that the suspect, Dean Arthur Schwartzmiller, was living in San Jose. The suspect befriended the victim by offering him gifts and inviting him over to watch movies and play video games. The suspect then sexually assaulted the victim in his home.

Detectives have learned that the suspect has lived in numerous states including New York, Idaho and Oregon. The suspect has had numerous aliases but has gone by the name Dean Schwartzmiller in California. The suspect is wanted in Oregon on felony sexual assault charges involving a minor. Detectives believe that the suspect has had numerous contacts with minors and are asking anyone with information on this suspect to contact them.

Detectives submitted this case to the Santa Clara County District Attorney's Office for review. A two million-dollar (\$2,000,000) felony arrest warrant was issued for his arrest.




