### **DETAILS:**

On Tuesday, September 6, 2005, at about 11:30AM, David Hezzelwood surrendered himself to the San Jose Police Department. He was wanted on a one hundred thousand dollar warrant for his arrest for two counts of Unlawful Sexual Intercourse with a minor, two counts of Oral Copulation with a Minor and one count of Child Annoyance.

Detective Robert Dillon began an investigation after the victim came forward to report the inappropriate sexual activity. Hezzelwood is a former history teacher at Oak Grove High school.

Hezzelwood was booked into Santa Clara County Jail. Detectives believe there may be additional victims in this case and are asking anyone with information to contact them.
