DETAILS:

On Thursday, July 14, 2005, at 5:47 PM, the San Jose Police and Fire Departments responded to the 1900 block of Cape Horn Dr. on a report of an unconscious baby not breathing. An ambulance transported the victim to a hospital where she was pronounced dead.

An autopsy was performed on the victim. The cause of death was determined to be blunt force injury to the head.

Chad Reager was arrested on 07-20-05 and booked for Murder. Anna Austin was arrested on 07-21-05 for Causing Willful Harm or Injury to a Child. On 07-21-05, the Santa Clara County District Attorney's Office charged Anna Austin with Causing Willful Harm or Injury to a Child. Chad Reager was charged with Assault Resulting in Death of a Child under 8.


Anna is the victim's biological mother. Chad is Anna's boyfriend, but is not the victim's father.
