### DETAILS:

On Monday, December 12, 2005, at approximately 10:31 PM, San Jose Police Officers responded to the 200 block of N. White Rd. regarding shots fired in the area. Upon arrival, officers found the victim lying on the ground with multiple gunshot wounds. The victim was transported to a local hospital where he died a short time later.

The suspects are described as four Hispanic or Black males, in their late teens/early 20's, wearing dark clothing. The suspects fled the scene on foot. No motive has been established for this case.

### UPDATE: 12-15-05

Follow up investigation by Homicide detectives led to the identification of both suspects. On 12-13-05, San Jose PD arrested Elidio Barragan in San Jose. On 12-14-05, Sacramento PD arrested Anthony Owens in Sacramento. They were booked into Santa Clara County jail for murder.


