DETAILS:

On 5-6-06 at 12:33AM, San Jose Police Officers responded to a major injury auto-pedestrian traffic collision on Almaden Expressway at Camden Avenue. On arrival, officers discovered the body of an adult male in the roadway. The adult male was pronounced dead at the scene, the victim of an apparent hit-and-run collision.

Traffic Investigators responded to the scene. Preliminary investigation indicates that the victim was on foot, crossing Almaden at Camden in an east-to-west direction on the south side of the street. He was struck and killed by a passing vehicle that was northbound on Almaden Expressway. The driver of that vehicle fled the scene.

A short time later, San Jose Police Officers responded to a nearby neighborhood on reports of a suspicious person in the area. When officers arrived, they found the vehicle involved in the earlier fatal collision and also discovered the driver sitting nearby. He did not live in the immediate area. The driver was arrested and booked into the Santa Clara County Main Jail on charges of felony hit-and-run and felony driving under the influence.
