SUSPECT VEHICLE: A late model 1990's, 4dr. gold or beige Ford Sedan (similar to a Crown Victoria)

DETAILS:

On 9-9-06 at about 4:50PM, the 16-year-old female victim was seated in her vehicle in the 3000 block of Sweigert Ave. when two suspects drove up next to her in a late model 1990's Ford Sedan. Suspect #1 exited the vehicle and approached the victim. Suspect #1 displayed a possible police identification and stated that he was with the Police Department. He ordered the victim to roll down her window and she refused. Suspect #1 ordered the victim out of her vehicle and again she refused. Suspect #2 remained in the passenger seat and alerted suspect #1 when a witness arrived on scene. The suspects fled the area and are currently outstanding.
