### UPDATE

**DETAILS:** On September 16, 2006, at approximately 0233 hours, the San Jose Police Department responded to 1642 Trieste Court on a report of a man stabbed at a house party. Responding units found Tuan Vo dead on the front sidewalk of the house. Witnesses at the house party stated that Tuan Vo was involved in a fight with numerous Asian male suspects in front of the residence. Witnesses observed Tuan Vo being punched and kicked while lying in the middle of the street surrounded by suspects. Witnesses also stated that the suspect group had previously been inside the house party, but had been asked to leave because it was getting late and they had been too rowdy.

Homicide investigators have arrested four suspects involved in the assault and murder of the victim, a student at a local college with no prior criminal record and three days shy of his 23<sup>rd</sup> birthday.
