### **DETAILS:**

On 4-28-07 at approximately 4:26AM, a citizen called 9-1-1 to report three suspicious persons leaving the side yard of a neighbor's house on Trovata Court.

San Jose Police Officers immediately responded to the location and confirmed that entry had been made into the neighbor's house and that property had been stolen. Officers spotted a suspicious vehicle matching the description provided by the witness and stopped the vehicle at San Felipe Road and Yerba Buena Road. Inside the car was property taken from the victim residence. Three suspects in the vehicle were arrested at the scene.

Burglary Detectives developed information implicating a fourth suspect, who was later arrested.
