DETAILS:

On 7-5-07 an armed bank robbery occurred at the Bank of America, at 6490 Camden Avenue. On 7-12-07 an armed bank robbery occurred at the Citibank, located at 3510 Leigh Avenue.

The suspect would drive a stolen motorcycle to the bank. He would then drive away on the stolen motorcycle and abandon it several blocks away. The Suspect would then drive off in his own truck.

Timothy Smedely has been arrested and charged with both bank robberies. Suspect Smedely is also suspected in numerous residential burglaries throughout San Jose and surrounding cities. The suspect is a contractor and it is believed that he is responsible for numerous burglaries over the last several years. The suspect will go to a victim's house under the guise of bidding for a construction job. The victim's home would then be burglarized at a later time. The suspect is most recognized for working on re-finishing floors.
