### DETAILS:

On Sunday, July 29, 2007, at 9:28PM, San Jose Police Officers were dispatched to multiple reports of shots fired in the area of Canoas Garden Avenue at Almaden Road. Officers arrived and located two victims with gunshot wounds. The victims were transported to a local hospital where one later died.

### UPDATE (07/31/07) :

Investigators during follow up investigation have identified the suspect as Clayton Clark and a warrant for murder has been issued. Investigators discovered the suspect left the scene with Yolanda Marie Cisneros (11/4/78) who is his current girlfriend along with her three children, Irene (1/21/95), Elizabeth (5/4/02) and Adam (5/21/04). Due to the violent nature of the crime we want to ensure the safety of Yolanda and her three children. We consider the suspect to be armed and dangerous. The suspect was last seen driving a 98 Ford Mustang #4DRP216, blue or purple in color.

Photos of Suspect Clark, the suspect vehicle and Yolanda Cisneros will be available at the Police Department.
